Privacy Policy

1. Introduction

This privacy policy prescribes how DID-GLOBAL Co.,LTD. a company located in Japan with its address in 2-3-14 Uchihiranomachi, Chuo-ku, Osaka, 540-0037 Japan (herein referred to as "DID-GLOBAL", "We", "us", "our") which uses this website https://apjdidglobal.com("this website") handles personal information that we collect, process and use from customers using our internet website (referred as "customers", "users", "you").

This privacy policy applies to all personal information we collect or process about you.

We are aware of our responsibilities to protect your personal information, and to comply with applicable privacy and data protection laws.

Personal data will be collected through these means.

- Use of websites owned, controlled or operated by DID-GLOBAL (including this website. "our Website")
- Communication between customers and DID-GLOBAL via Email, or other tools such as internet communication services (e.g. VoIP, Skype, FaceTime) or social networking services etc.
- Viewing and using DID-GLOBAL's social media page
- Contact, inquiries etc. from other websites posting DID-GLOBAL's advertisements
- Applications and contract actions etc. for DID-GLOBAL's rental properties or rental products
- Applications and contracts action etc. via this website for the rental properties or rental products which are posted on this website

By using DID-GLOBAL's services ("our Services") means you accept the terms of this Privacy Policy, and you agree to use our Services at your own discretion.

You must be a legal adult according to Japanese law or be supervised by a parent or guardian to use our Services. Online applications by minors will not be accepted.

2. Collection of Personal Information

For the purpose of this privacy policy, Personal Data refers to any information regarding a natural person, a legal person, an institution or an association, which is, or can be, identified, even indirectly, by reference to any other information, including a personal identification number.

And, Usage Data refers to information collected automatically from our Services (or third-party services employed in our Services), which can include all or a part of: the IP addresses or domain names of the computers utilized by the Users who use our Services, the URI addresses (Uniform Resource Identifier), the time of the request, the method utilized to submit the request to the server, the size of the file received in response, the numerical code indicating the status of the server's answer (successful outcome, error, etc.), the country of origin, the features of the browser and the operating system utilized by the User, the various time details per visit (e.g., the time spent on each page within the website) and the details about the path followed within the website with special reference to the sequence of pages visited, and other parameters about the device operating system and/or the User's IT environment.

- Information on income

2) Usage Data

When customers use our Website, DID-GLOBAL may collect information including but not limited to customer's IP address, location information, information about the device you are using, log files and certain information about you via cookie technologies. We also collect and process aggregated and statistical data about your usage behavior via Google Analytics and other analysis services. These data generally do not identify you personally or are not directly related to a specific person.

3. Use of Personal Information

DID-GLOBAL uses your Personal Information for the following purposes.

- To conclude and implement contracts including lease contracts.

4. Handling of Personal Information

In order to enhance the services provided to customers by our company, we may occasionally entrust the management of individual services to our affiliates ("Contractors").

5. Maintaining the Confidentiality of Personal Information

- 3. To take urgent actions to secure the physical safety of the customers, the general public, our employees and Contractors.

6. Your rights with respect to Personal Information

Customers have the following rights with respect to the personal data concerning you.

- Right to data portability.

7. Reformation of Personal Information

DID-GLOBAL will immediately respond in principle to requests for disclosure, correction, deletion and cessation of personal information, after confirming the identity of the applicant. This will be completed within a reasonable period of time.

8. Information Protection Measures and Retention Period

DID-GLOBAL will implement technical and organizational measures to ensure a level of security appropriate to the risk to the personal information we process, and perform review and improvement work on a regular basis. Our staff will share information on information protection measures.

The Personal Data retention period is the period necessary to provide our Services, and the period required and permitted by applicable laws, and it is currently no less than 7 years. Customers can always request that we suspend or remove the data by contacting us.

9. Payment Service Provider

The payment service in the online application procedure of this website is held at Zeus Co., LTD. ("ZEUS"). With regard to the processing of personal data in the payment service by ZEUS, the privacy policy of ZEUS is applied. Payment data will be conveyed directly to ZEUS and will not go through DID-GLOBAL and the server of this website.
